

BOARD MEETING SUMMARY
APRIL 25, 2011

The board meeting opened with the call to order (all members present), roll call, Pledge of Allegiance, invocation, and the reading of the District's Mission Statement. Mr. Tim Beneke, Board President, acknowledged Mr. Jacob Hickey, Play Director, the cast and the support staff. The Board expressed its appreciation on behalf of the school district for the play *Disney's Aladdin, Jr.* and had all participants state their role in the production.

Administrative reports were presented. Senate Bill 210, entitled Healthy Choices for Healthy Children, garnered much discussion. This legislation significantly regulates food service standards, including potential changes to physical education; all requirements are to be implemented beginning July 1, 2011. As part of his report, Mr. Sean Maggard, Legislative Liaison, also shared information concerning Senate Bill 210 as well as Senate Bill 5. Mrs. Rachel Tait, Treasurer, presented the financial reports, all of which were approved.

Two items of old business appeared on the agenda and were approved: 1) Policy GBC-2, Certified Staff Contracts and Compensation Plans (Administrators), and 2) Policy, BCCC, Treasurer's Contract. New business items included approval of the TVS FFA overnight trip to the FFA State Convention, an amendment to the 2011-2012 school calendar with three (3) waiver days and four (4) early release days for teacher professional development activities, maintaining the half-day, every day kindergarten program, recognition of the five (5) calamity days which should be waived by the Ohio Department of Education, and recognition of the six (6) additional calamity days and the respectively listed make-up days.

- Two-year contracts for Sandra Chapman – Educational Aide*, Dean Fudge – Bus Driver, Renee Hansford – Educational Aide, Michelle Hickey – Food Service, Amy Pemberton – Educational Aide*, and RaeAnne Wiegand – Bus Driver.
