BOARD MEETING SUMMARY OCTOBER 25, 2010

The board meeting began with the traditional opening. Mr. Beneke asked that the minutes from the September, 2010 board meeting be amended to recognize Mr. Michael Blankenship and two vocational agriculture students, Michael Randolph and James Cottingim, as speakers in support of the FFA and FFA Alumni receiving permission to farm the school district's land to the west of the school.

Terri Freeman, Interim Treasurer, provided a summary of the financial reports. Assistant treasurer Rachel Tait led the board through the five-year financial forecast. All financial agenda items were approved. As part of new business a resolution was approved seeking a waiver from administering a body mass index screening of students. Contracts with the Ohio School Boards Association, the Southwest Ohio Computer Association, and Paul Wesler, State Certified Bus Instructor, were approved. Additionally, field trips to Camp Kern and the FCCLA National Cluster were approved, professional leave requests for Diana Cain, Lindsey Gregg, Margaret Krauss, and Beth Wilmoth were approved, and the position of Reserve Wrestling Coach was approved.
